This agreement is made on the date set forth below between the Plainfield Shorewood Area Chamber of Commerce Inc. (hereafter "Chamber") and the member firm service purchaser (hereafter "customer") noted below.

1. AGREEMENT: Chamber agrees to provide and customer agrees to subscribe the type of Plainfield Connection Service set forth below.
2. PRICE: Customer agrees to pay the price as set forth below. **(\$100.00 a month)** Add-ons can be purchased
3. TERM: Customer agrees to pay the \$100.00 each month upon receipt of statement from PSACC office or sales receipt if credit card is on file. A LATE FEE of \$25.00 will be added IF behind on payments past 30 days.
4. REPRESENTATION: The customer hereby authorizes the Chamber to represent them with its Plainfield Connection service through the bag and online through our Plainfield Connection Social Media page and portal. PSACC Board Members, Ambassadors and staff will represent the products and/or services to the resident as instructed by the customer. Bag drops are acceptable.
5. COUPONS/PROMOTIONAL ITEMS: Customer may furnish a coupon and/or brochure or promotional item to be distributed through the Plainfield Connection program. **It is the customers' responsibility to arrange delivery of items to the Plainfield Shorewood Chamber office. If your company is out of items, you will still be charged.** The materials may be changed at any time at the discretion of the customer. The Chamber reserves the right to review and/or reject any materials, which are deemed to be objectionable; such as but are not limited to, subject matter or phraseology that opposes either Chamber or public policies.
6. LIABILITY: The Chamber shall not be liable for any loss or damage of any kind resulting from the delay or the inability to include the coupon in the Plainfield Connection Program in a timely manner as a result of any cause beyond the Chamber's control.
7. CONTRACT LIFE: It is understood that the services herein contracted for will continue from the date of the beginning of the service until either party shall give the other party **written notice** of cancellation at their official address; provided, however, that the customer cannot cancel during the first three months of service.
8. REPORTS: The Chamber will furnish to the customer a written report of the names, addresses and other pertinent information of the new & old residents contacted by the Greeter Service on behalf of the customer, via e-mail or hard-copy monthly. It is understood and agreed that these reports are confidential and for the customer's use only, and that they have a unique and special value. In the event that the customer shall breach the provision of this paragraph, the Chamber may immediately cancel the contract and have all such rights and remedies that are available and in equity incurred as a result of said breach.
9. CONTROLLING PROVISIONS: The terms and conditions of this contract shall supersede any provisions, terms or conditions contained in any prior agreement, either written or verbal, and the rights of the parties shall be governed exclusively by the provisions, terms and conditions hereof.
10. SERVICE PRICE: Plainfield Connection member will be charged at the rate of \$100.00 each month which will include 100 visits per month. \$50.00 startup fee.
